WHAT TYPE OF PERSONAL INFORMATION DOES MANGO COLLECT?

FOR WHAT PURPOSE DO WE PROCESS YOUR PERSONAL DATA?

HOW LONG DO WE KEEP THE DATA?

WHAT AUTHORISES US TO PROCESS THE DATA?
